- 2) Site plan showing the location of the building and or driveway and any existing buildings along with measurements of setback from side and rear lot lines and from the center of any public or private road.
- 3) Letter from County Sanitarian regarding type and size of sewage disposal system. *No Permit will be issued without Sanitary Permit# _____ (submit copy of permit)*
- 4) When complete contact the Town Chairman, Paul Peterson to obtain the permit (493-0528 after 3:00pm) or return application to the town office. This project will require inspection permits if one or two family new home, addition over \$50,000.00. or Commercial building requiring state inspection.
