# 5. ARCHITECTURAL REVIEW OF PROPOSED EQUINE CAMPGROUND LOCATED ON THE EASTERLY END OF 5086 COUNTY ROAD I. OWNERS, DAVID & PENNY GEITNER.

DAVID GEITNER ADDRESSED THE COMMISSION WITH AN OVERVIEW OF THE PROJECT. THE MAIN BUILDING WILL BE 56' X 42' WITH 6 FOOT OVERHANG. TIN SIDING AND ROOFING. THREE SEASON TYPE BUILDING WITH BATHROOMS, SHOWERS AND STORE AREA.
